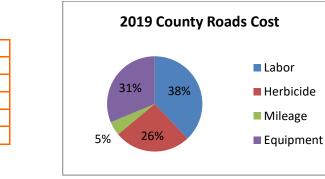
The District offers a rebate program to landowners that hire a commercial applicator to treat Prairie Dogs using ZP Oats on their private land.

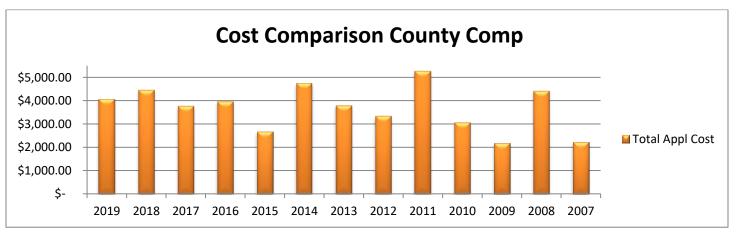

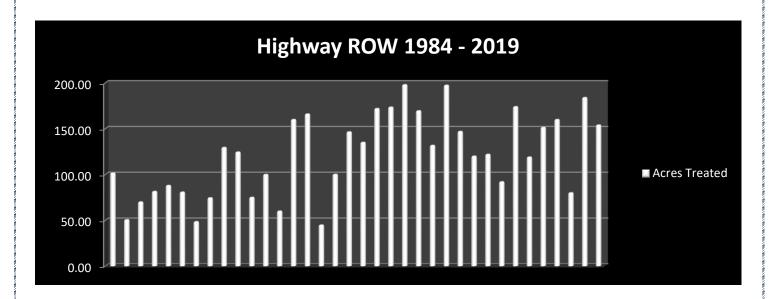
#### 2019 County Comp

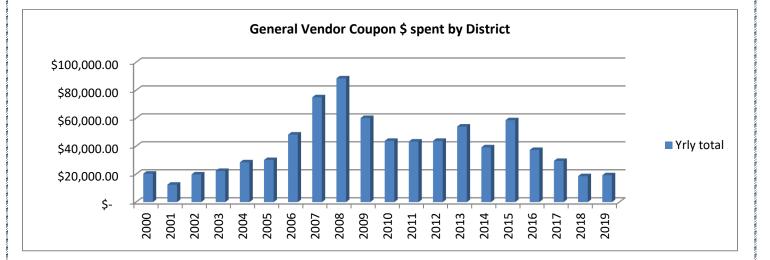

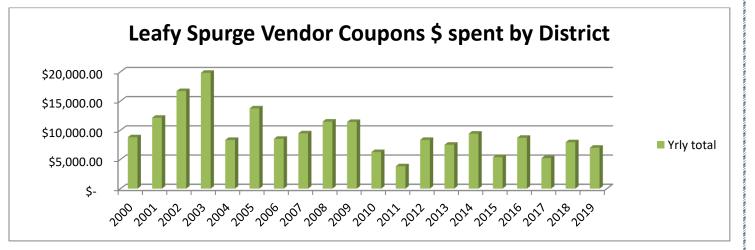
District cost share on Designated and Declared weeds is 70/30 with the exception of Leafy spurge, the District pays 100%, as allowed by statue.

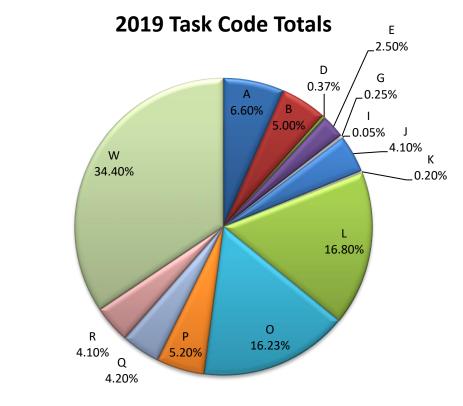




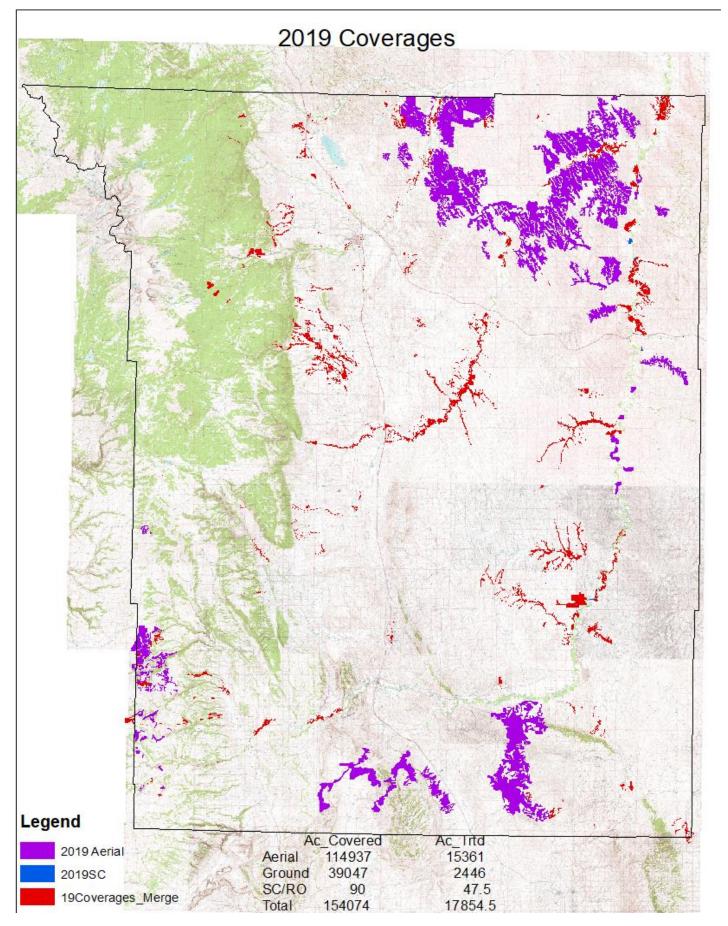
#### 2019 Employees Time Spent

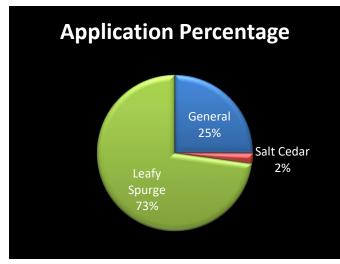


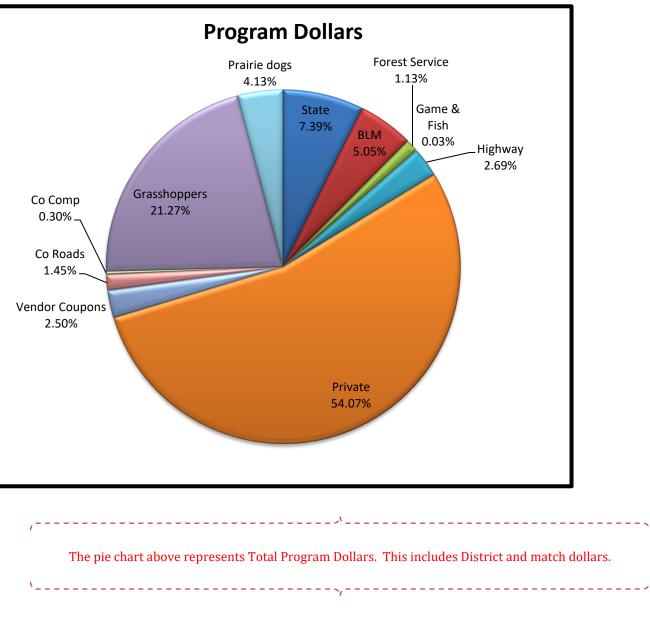




The map shows the acres covered by the District in 2019. 463 application records were processed during the year.

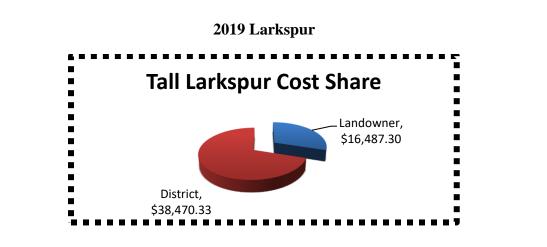

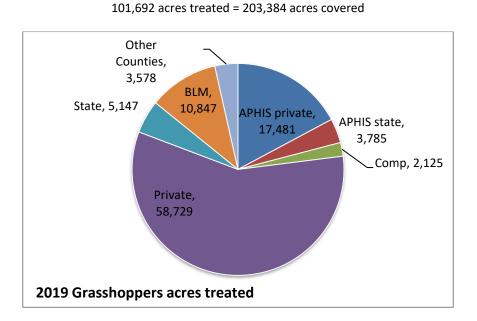

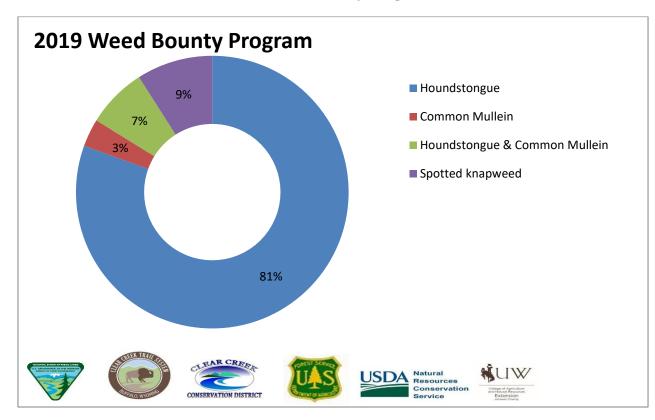
