The District offers a rebate program to landowners that hire a commercial applicator to treat Prairie Dogs using ZP Oats on their private land.

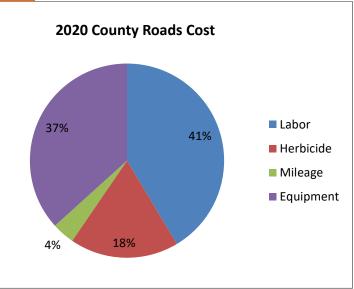

## **2020 County Roads**

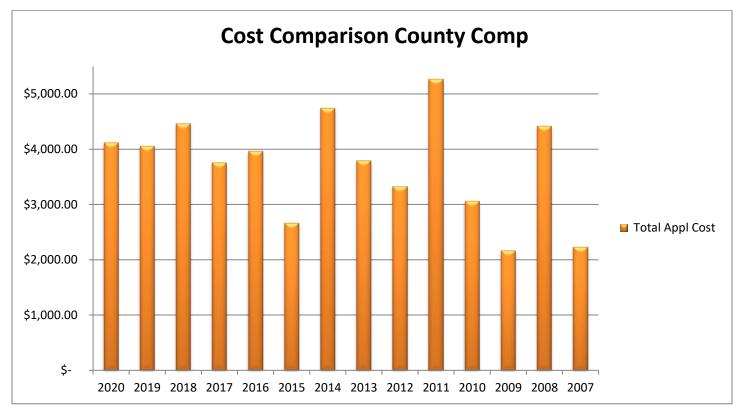
In 2020 the District treated 437 acres/672.45 miles on county roads.

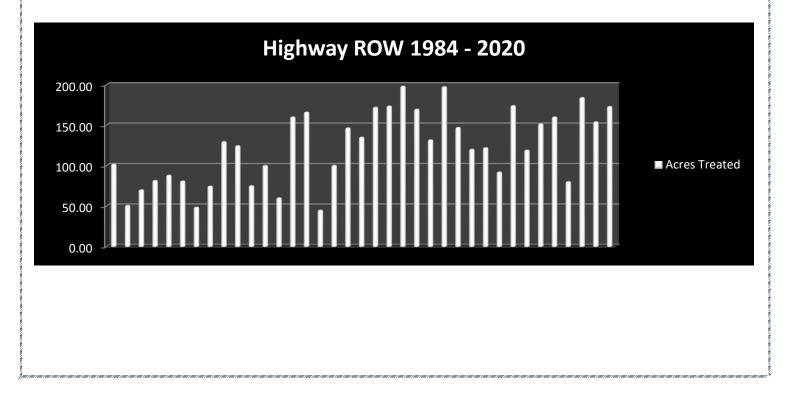
#### 2020 County Comp

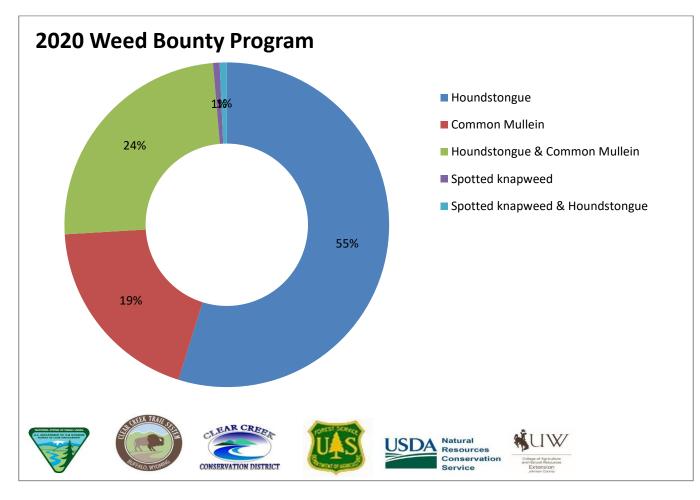

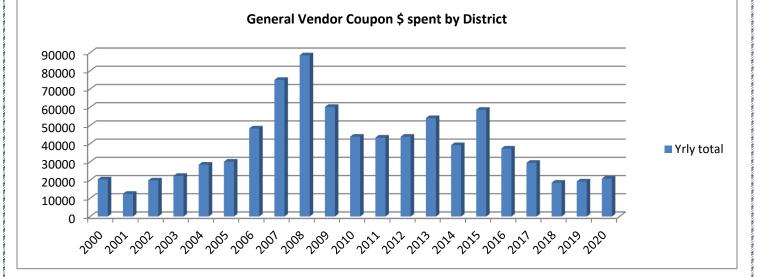
#### 2020 Weed Bounty Program



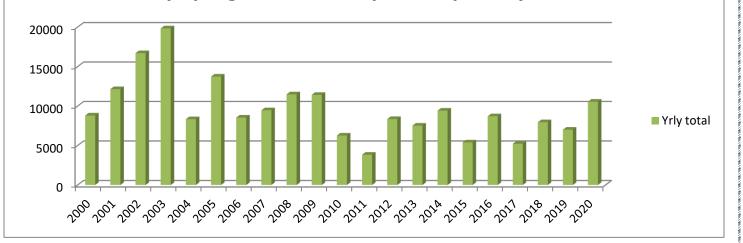

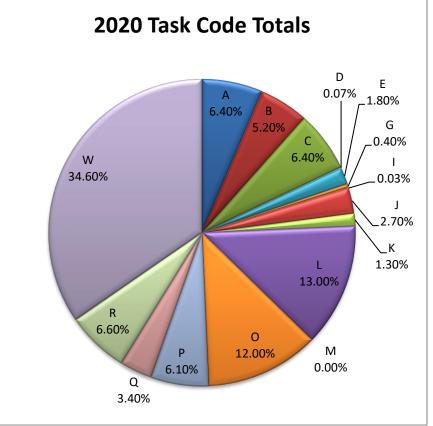
Leafy Spurge Vendor Coupons \$ spent by District

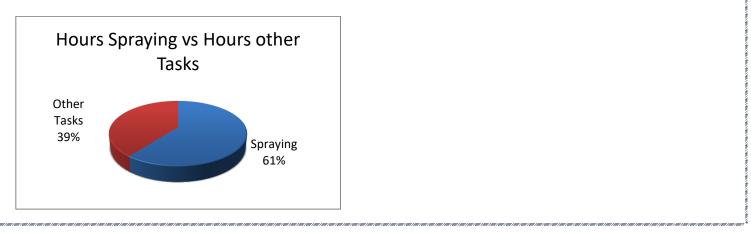


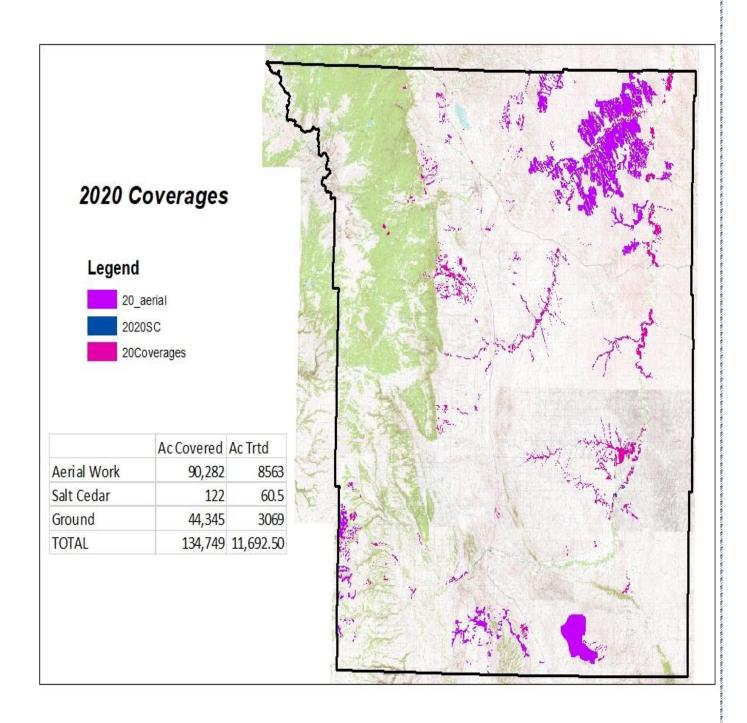
#### 2020 Employees Time Spent

The District has assigned the following task codes in order to track were the employees time is spent. The graph includes all employees time. We also assign labor rates and track each task code for each labor rate.

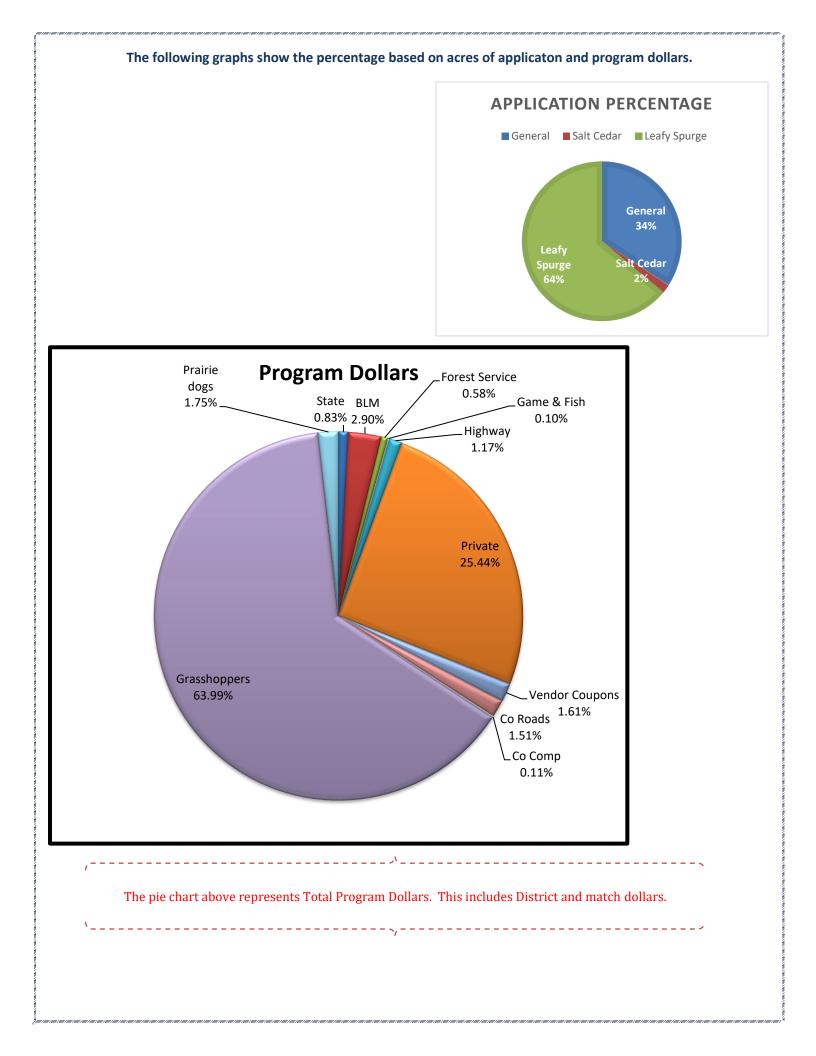
