Meeting was called to order at 5:10 pm by Chairman Lutterman. Minutes for the June 29th meeting were approved with a motion by Scott R. and a second by Dick. Financial Statements for July were reviewed. Approval of July financial statements was tabled pending corrections to budget. Scott R. moved to pay the vouchers and to allow the clerk to write utility, salary, salary related assessments and staff benefit checks as needed. Motion passed after a second from Dick.

## Old Business:

Rod gave an activity update: Tall Larkspur spraying has been completed with more ground being covered this year; Back Country spraying did not cover what they had said they would; foot crews have all been willing to work hard and put in extra time this year; kinda getting caught up and will be start losing crew members next week. VO Ranch became a challenge this year because of the trees, tried using Milestone on the Leafy Spurge because it was safe for the trees; but, Larry wants some of it resprayed. Unfortunately, some of the helicopter work does not look good there either. All the moisture mave have something to do with the poor control. Rod announced that the commissioners had signed the final budget. Rod reported that there was a 100 +/- area of Ventenata to be sprayed. It is all in a subdivision with an HOA with the exception of one landowner that Rod is trying to contact. The approximate cost will be \$6500. It was agreed by general consensus to cost share 80/20. Rod lead discussion on the property next door and presented the appraisal. Rod will visit with the owner before the next meeting. Scott R. moved to pay the invoice of \$3,000 for the appraisal. Motion passed after a second from Dick. Rod reported that he has been receiving numerous complaints regarding high numbers of Grasshoppers. It is too late in the season to do anything so APHIS is doing adult surveys to give an idea of what to expect for next year. The Board decided to place an advertisement in the Buffalo Bulletin to let landowners know what was happening with the Grasshoppers.

## New Business:

Rod announced that the Area 2 meeting will be on August 23<sup>rd</sup> in Sundance if anyone would like to attend. Rod reported that an infestation of Hoary Alyssum on Rock Creek warrants treatment and asked the Board if they would like to add it to the County Declared list. It was agreed to hold a public hearing at the next board meeting regarding that.

There being no further business, the meeting was adjourned by unanimous ballet at 6:30 pm. The next regular business meeting will be September 6th at 5:00 pm.
