JOHNSON COUNTY WEED & PEST CONTROL DISTRICT BOARD

Meeting was called to order at 5:00 pm by Chairman Rogers. Minutes for the June 3rd meeting were approved with a motion by Tyler and a second by Dick. Financial Statements for June were reviewed. Randy moved to approve the financial statements for the general and leafy spurge funds for June. Tyler seconded the passing motion. Dick moved to pay the vouchers and to allow the clerk to write utility, salary, salary related assessments and staff benefit checks as needed. Motion passed after a second from Nathan.

Under old business, Rod gave a report on accounts receivable, total outstanding to date is \$ 3,071.05. The outstanding bills are for sterilant work on county entities, some 2020 grasshopper, one 2019 grasshopper payment and a couple of customer orders. Rod gave an activity report. Mark with Frontier started the first part of June spraying Leafy spurge and had to be at another job on June 20th; but, completed Powder River and Crazy Woman before leaving; Jim with Frontier did some Leafy spurge and then went to Kaycee to spray Scotch thistle at Taylors and TTT; Shay with Reno Air has finished Leafy spurge spraying at Landeck and up Clear Creek and Tony with 307 Aviation is spraying Tall larkspur on the mountain. The foot crew has been spraying larkspur on the mountain and hopefully will finish tomorrow. Places are looking good where they have been sprayed before; but, it maybe due to the second dry year affecting growth. There are 5 on the foot crew one, lost one by mutual agreement. It is a challenge this year without any returning crew members. The contract crews are going good. Sam's crew is on the mountain getting a lot covered. Rod told the Board that his ATV had rolled off a cliff destroying it and the Districts tank that was on it. Rod announced that the University of Wyoming is hiring a new weed specialist. Rod got to sit in on presentations from four candidates. It was very interesting to be a part of it. Rod explained that the job breakdown is 50% extension, 25% research and 25% classroom. Rod reported that grasshoppers are blowing up on the mountain. APHIS has gotten 20 to 40 counts in that area. It was difficult to find someone that could get it sprayed; but, found HeliWorks out of Montana to do the job. There will be between 12,000 to 15,000 treated acres in two blocks with some of that being in Washakie County. There is a little BLM money; but, it is unknown if there will be any State funds for the approximate 1,000 acres of State lands. Rod projected the cost to be \$4.50 per treated acre. It was agreed by general consensus to charge the landowner \$2.00 per treated acre. Rod announced that the flatbeds had been moved and are being stored at the south end of the building and asked the Board if they wanted to sell keep them. Nathan moved to sell the 7x9 flatbed for \$500. Motion passed unanimously after a second from Tyler. Rod reported that he and Chairman Rogers had met with the County Commissioners regarding the budget. They are happy with the budget. Rod has talked with the Commissioners regarding the valuation. It is expected to be at \$247,000 per mil with \$223,000 of that being "collectable". For FY 20/21 the collectable amount was \$255,000. The District may have to move funds for reserves. The budget hearing is set for July 8th, 7 pm at the Harold Jarrard Park in Kaycee. Rod lead discussion on the Board Tour set for that day. Andrew, Crook County Supervisor, will be bringing his drone to do a tour of the Salt cedar/Russian olive project last winter on Reculusa Ranch and BLM of what was done and what is to come. Rod announced that he has not heard back regarding the Eco Paks. Katie reported that there has been approximately 2960 pounds of weeds brought in to date, mostly Houndstongue and at the Weed Pull Day resulted in 1246 pounds pulled.

There being no further business, the meeting was adjourned by unanimous ballet at 6:10 pm.
